**TERMS AND CONDITIONS**

**Terms: Net 10 Days**

1. Customer acknowledges that he/she has been fully instructed (through practical demonstration) by **Dassel's** in the proper use of dispensing system and that he/she will not allow his/her employees/agents to use the system unless they are fully instructed as to proper use, by undersigned or at undersigned's request by Dassel's.
2. Customer acknowledges that he/she understands the hazards associated with petroleum products flammability, especially propane and the hazard of overfilling propane tanks.
3. Customer agrees to hold Dassel's Petroleum harmless from any losses resulting from his/her use of keylock/cardlock facility.
4. Either party may terminate the contract by giving the other party 30 days notice in writing of termination of the contract.
5. If suit is commenced to collect any money due under this contract, to recover possession of any keys/cards or to enforce any provision of this contract, the prevailing party shall be entitled to judgement for all costs of collection, repossession of keys/cards and reasonable attorney fees in bringing the suit and enforcing any judgement granted therein.
6. All sales shall be subject to vendor's standard terms and conditions of sale as they exist at the time of the sale.
7. For commercial accounts, signing of this document also personally guarantees payment of account.
8. Customer hereby authorizes Dassel's to fill owned or rented tanks on a regular basis on route, until Dassel's is notified in writing to terminate deliveries.
9. No "will call" deliveries.

**AGREEMENT AND GUARANTEE**

I have made the above statements for the purpose of obtaining credit. I certify they are true and authorize you to make credit inquiries if necessary. Billing shall be issued twice each month and payment will be due **10 days from date of invoice**. I agree to pay a late charge of 1 1/2% per month or \$.50 minimum on any delinquent balances. This agreement includes the terms and conditions above hereof, and Dassel's Petroleum, Inc.'s standard terms and condition of sales, as they exist from time to time.
